

## Vision Insurance

### With your Vision Preferred Provider Organization Plan, you can:

- Go to any licensed vision provider and receive coverage. Just remember, your benefit dollars go further when you stay in-network. If you choose an out-of-network provider you will have increased out of pocket expenses, pay in full at the time of services, and file a claim with MetLife for reimbursement.

### In-network benefits

There are no claims for you to file when you go to an in-network vision provider. Simply pay any copays or member out of pocket expenses and, if applicable, any amount over your frame/contacts allowance at the time of service.

### Eye Exam

#### One per calendar year

- Eye health exam, dilation, prescription, and refraction for glasses: Covered in full after a **\$0** copay<sup>1</sup>

### Frame

#### One per 2 calendar year

- Participating Providers<sup>2</sup> - Allowance: **\$130** after **\$25** eyewear copay<sup>1</sup>

### Standard Corrective Lenses

#### One pair per calendar year

- Single vision, lined bifocal, lined trifocal, lenticular: Covered in full after **\$25** eyewear copay<sup>1</sup>

### Contact Lenses (instead of eyeglasses)

#### One allowance per calendar year

- Contact lens fitting (standard\*): Covered in full after **\$15** copay
- Contact lens fitting (specialty\*): \$50 retail allowance after **\$15** copay
- Elective lenses: **\$130** allowance
- Necessary lenses: Covered in full

\* Standard contact lens fitting applies to a current contact lens user who wears disposable, daily wear, or extended wear lenses only. Specialty contact lens fitting applies to new contact wearers and/or a member who wear toric, gas permeable, or multi-focal lenses.

### Discounts on Non-Covered Exam, Services, and Material<sup>3</sup>

- Exams, frames, and prescription lenses: 30% off retail
- Contacts, miscellaneous options: 20% off retail
- Disposable contact lenses: 10% off retail

### In-Network Value Added Features:

**Laser vision correction:** Savings of 40% - 50% off the national average price of traditional LASIK are available at over 1,000 locations across our nationwide network of laser vision correction providers. Contact QualSight LASIK at (877) 201-3602 for more information.

**Additional savings on glasses and sunglasses<sup>3</sup>:** 20% savings on additional pairs of prescription glasses and nonprescription sunglasses, including lens enhancements.

**Additional savings on lens enhancements<sup>3</sup>:** Average 20-25% savings on all lens enhancements not otherwise covered under the Superior Vision by MetLife vision benefit program.

**Additional savings on frames<sup>3</sup>:** 20% off any amount over your frames allowance.

**Retinal imaging:** Up to a **\$39** copay on routine retinal screening when performed by a private practice.

### Out-of-Network Reimbursement

You pay for services and then submit a claim for reimbursement. The same benefit frequencies for **in-network benefits** apply. Once you enroll, visit [www.metlife.com/mybenefits](http://www.metlife.com/mybenefits) for detailed out-of-network benefits information.

- Eye exam: up to **\$37 (ophthalmologist) or \$28 (optometrist)** after a \$0 copay

Materials allowance after a \$25 copay

- Frames: up to **\$61**
- Single-vision lenses: up to **\$35**
- Lined bifocal lenses: up to **\$50**
- Lined trifocal lenses: up to **\$60**
- Lenticular lenses: up to **\$95**
- Contact lenses: Elective: up to **\$100** and Necessary: up to **\$210**
